New England Prison Education Collaborative (NEPEC) Accelerator Grants Year 1 Proposal Form

The New England Prison Education Collaborative (NEPEC), with support from Ascendium Education Group, is pleased to release this Request for Proposals (RFP) for the inaugural round of NEPEC Accelerator Grants. In Year 1, NEPEC is prepared to award five Accelerator Grants to five eligible postsecondary institutions located across the New England states of Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont.

Each awardee will be working to increase Pell-eligible postsecondary programming within the state where they are located. This could include institutions with active Pell-eligible Prison Education Programs (PEPs) but also those at various stages in the development of such programs. Taken together, the five projects funded by these five inaugural Accelerator Grants will meaningfully advance NEPEC's mission to help actualize a future where every incarcerated person in New England has access to high-quality, workforce-aligned, equitable postsecondary opportunities with a diverse range of educational pathways. At the core of each funded project will be an unshakable commitment to holistic student support for learners at every step along the intake-to-reentry continuum
