<u>Proposed H.B. No. 5001</u> (Higher Education and Employment Advancement Committee)

AN ACT ENSURING THAT STUDENTS IN THIS STATE RECEIVE HIGH-QUALITY SKILLS TRAINING

To ensure that students in this state receive high-quality skills training in order to achieve well-paying careers in the state.

To establish the STEM Loan Subsidy Program to provide persons employed in science, technology, engineering or math fields with no or low interest student loans.

H.P. 121 (Rep. Ryan Fecteau)

AN ACT TO EXTEND THE REFUNDABILITY OF THE EDUCATIONAL OPPORTUNITY TAX CREDIT TO STUDENTS IN THE BEHAVIORAL HEALTH FIELD

This bill makes changes to the Competitive Skills Scholarship Program administered by the Department of Labor (DOL), including: (1) It requires that the DOL's outreach efforts regarding the program focus on unemployed/underemployed workers, veterans, immigrants, recipients of benefits under the statewide food supplement program, low-skilled manufacturing workers, and students enrolled in postsecondary education. (2) It directs the DOL to collaborate with other entities to improve program outreach to target demographics, including collaboration with the Maine Community College System (MCCS). (3) It makes changes to the criteria used to determine approved education and training under the program, including consideration of employer input, changing demographics and traditional industries in the State in which innovations and new technologies are creating a demand for skilled workers. (4) It requires that a program participant be given information about the allowable uses of a family development. (5) It adds a requirement that a participant be offered comprehensive career planning services prior to the program's development of an individual career plan. It directs the department to include in this partnership the MCCS with respect to participants enrolled or seeking enrollment in a training or education course provided by the MCCS. It also directs the MCCS to assist the DOL in program management and oversight for such participants. (6) It repeals the Jan. 1, 2020 repeal provision on the eligibility for the program of a full-time student at a public secondary school enrolled in a career and technical education program at a career and technical education center or a career and technical education region. This bill also amends the laws governing the employment of minors 16 and 17 years of age, providing that such a minor may be employed in an otherwise hazardous occupation for which the minor has been trained or certified from a vocational, career and technical or cooperative education program approved by the Department of Education only if the minor has graduated from the program and has graduated from high school.

H.P. 275 (Rep. Pinny Beebe-Center)

AN ACT TO EXTEND THE REFUNDABILITY OF THE EDUCATIONAL OPPORTUNITY TAX CREDIT TO STUDENTS IN THE BEHAVIORAL HEALTH FIELD

Provides that students receiving bachelor's degrees or associate degrees in a behavioral health field are entitled to a refundable income tax credit for certain education loans in the same manner as students receiving degrees in science, technology, engineering or mathematics.

Status: Introduced January 24, 2019

H.P. 345 (Rep. Mattie Daughtry)

AN ACT TO IMPROVE THE AFFORDABILITY OF HIGHER EDUCATION

Provides additional funding to the Maine State Grant Program in the 2020- 2021 biennium. It requires the Finance Authority of Maine to expand the Maine State Grant Program to enable more low-income residents to attend an institution of higher education in Maine. It also requires the Finance Authority of Maine and the Department of Health and Human Services to jointly examine ways to maximize the delivery of federally funded support services to postsecondary students.

H.P. 452 (Rep. Mattie Daughtry)

AN ACT TO FACILITATE THE PURCHASE OF TEXTBOOKS FOR LOW-INCOME COLLEGE STUDENTS

Amends the Maine State Grant Program, a grant program administered by the Finance Authority of Maine to award grants to Maine residents who are students at postsecondary institutions of higher education in this State based on financial need. Under the program, the minimum grant is \$1,000 per year. This bill allows the authority, using the same need and residency criteria as for the grants, to award up to an additional \$500 grant for textbooks per year.

<u>H.P. 468</u> (Rep. Kristin Cloutier)

AN ACT TO ATTRACT, EDUCATE AND RETAIN NEW STATE RESIDENTS TO STRENGTHEN THE WORKFORCE

Creates programs to provide education, services and training for the State's workforce immigrant populations: (1) Establishes the Welcome Center Initiative to operate welcome centers in adult education programs to provide education, services and training for foreign-trained workers in municipalities or regions of the State that have immigrant populations or that have industries that are experiencing a shortage of trained workers, patterned after the New Mainers Resource Center operated by the City of Portland adult education program. (2) It directs the Department of Education's (DOE) office of adult education and family literacy to: A. Administer a vocation-specific English language acquisition and workforce training program for immigrants in the State and establish a statewide competitive grant process to carry out the purposes of the program; B. Establish and implement a local community planning support program to provide a planning process for communities to provide English language acquisition and training in vocational skills, identify employers or areas that would benefit from immigrant residency or employment and cultivate community support to integrate immigrants into the communities and local workforce. The office must establish a 1 grant process to carry out the purposes of the program; and C. Develop and implement a grant process to award grants to adult education programs to increase English language acquisition instruction. (3) It directs the DOE to establish a welcome center under the Welcome Center Initiative within the City of Lewiston's adult education program to attract, educate and retain in employment foreign-trained workers, patterned after the New Mainers Resource Center in Portland, and provides funding for that purpose.

AN ACT TO INCREASE FUNDING FOR ADULT BASIC LITERACY, WORKPLACE EDUCATION AND COLLEGE PREPAREDNESS

This bill provides an increase in funding for the adult education subsidy to local school units that operate adult education programs. It also provides targeted funds to improve the capacity of local adult education programs to meet students' academic and work readiness and training needs.

H.P. 538 (Rep. John Schenk)

AN ACT TO PROMOTE KEEPING WORKERS IN MAINE

Would prohibit an employer from requiring or entering into a non-compete agreement with an employee earning wages that are at or below 300% of the federal poverty level. If an employer requires a non-compete agreement for a position of employment, the employer must disclose that requirement in any advertisement for that position, and an employer must provide an employee or prospective employee with a copy of a non-compete agreement at least 3 business days before requiring that employee or prospective employee to sign the agreement. An employer that violates this law commits a civil violation for which a fine of not less than \$5,000 may be adjudged. The bill would also prohibit a restrictive employment agreement between 2 or more employers that prohibits or restricts one employer from soliciting or hiring another employer's employees or former employees.

H.P. 574 (Rep. Denise Tepler)

RESOLVE, TO DIRECT THE COMMISSIONER OF PROFESSIONAL AND FINANCIAL REGULATION TO CREATE A WORKING GROUP TO STUDY CREDENTIALING SKILLED INDIVIDUALS WITH FOREIGN CREDENTIALS

This resolve directs the Commissioner of Professional and Financial Regulation to create a working group to study credentialing skilled individuals with foreign credentials in the State. The working group consists of 8 to 10 members representing licensing boards and professional organizations served by the licensing boards in professions for which there is a need for and an opportunity to credential skilled individuals with foreign credentials. The working group is required to submit its report along with any recommendations and suggested legislation to the Governor and the Commissioner of Professional and Financial Regulation. The commissioner is required to submit the report with any recommendations and suggested legislation to the Joint Standing Committee on Labor and Housing. The committee is permitted to report out a bill relating to the subject matter of the report to the First Regular Session of the 130th Legislature.

H.P. 587 (Rep. Erik Jorgensen)

AN ACT TO INCREASE FACULTY IN NURSING EDUCATION PROGRAMS

This bill amends the nursing education loan repayment program as follows: (1) It extends eligibility to apply to individuals who are currently enrolled in master's or doctoral degree programs; (2) It specifies that applicants must indicate an intention to work as full-time nursing faculty in a nursing education program in the State, and increases the required commitment from 3 to 5 years after acceptance into the nursing education loan repayment program; (3) It increases the maximum amount of loans eligible for repayment under the program from \$4,500 to \$30,000 for a master's degree, and from \$6,000 to \$60,000 for a doctoral degree.

<u>H.P. 646</u> (Rep. Anne-Marie Mastraccio)

AN ACT TO FORGIVE EDUCATION DEBT FOR CERTAIN HEALTH CARE PROFESSIONALS WHO WORK IN THE STATE

This bill creates the Health Care Professional Education Loan Repayment Program administered by the Finance Authority of Maine to repay the education debt of certain health care professionals who agree to live and work in the State for a minimum of 5 years. Under the program, the authority will pay 20% of the education debt or \$25,000, whichever is lower, for each year of participation in the program up to a total of \$125,000 for a health care professional who is not employed in a federally designated health professional shortage area and 20% of the education debt or \$30,000, whichever is lower, for each year of participation in the program up to a total of \$150,000 for a health care professional who is employed in a federally designated health professional shortage area. This resolve establishes the Task Force To Study the Creation of a Comprehensive Career and Technical Education System to examine the feasibility of establishing a comprehensive 4-year high school career and technical education program to provide a technical high school setting for middle school students to attend at the completion of the 8th grade.

AN ACT TO ENSURE THE INTEGRITY OF FOR-PROFIT COLLEGES

This bill requires annual review of for-profit colleges by the State Board of Education to ensure that they are meeting adequate educational standards. If the board finds that a for-profit college is not meeting the standards, the board may terminate the degree-granting authority of the for-profit college.

AN ACT TO AUTHORIZE A GENERAL FUND BOND ISSUE TO PROVIDE STUDENT DEBT FORGIVENESS TO SUPPORT WORKFORCE ATTRACTION AND RETENTION

This legislation would protect Mainers from predatory student loan practices. It would create a "Student Loan Bill of Rights," a statute that makes several changes within the Maine Bureau of Consumer Credit Protection (BCCP). The current amended version of the bill does 3 things: (1) it creates a registration procedure for loan services, which requires they submit an application to the Superintendent Maine BCCP for approval, (2) it identifies prohibited acts, including misleading student loan borrowers and fraud, and requires loan servicers comply with federal law, and (3) it allows the Superintendent to investigate student loan servicers to ensure compliance with the law.

This resolve directs the Department of Economic and Community Development to design and implement a one-year pilot program to encourage remote workers to relocate to Maine. The pilot program, the New Remote Worker Grant Program, will award grants of up to \$2,500 per qualifying individual and up to \$125,000 in total funds for qualifying expenses. The resolve directs the department to report back to the joint standing committee of the Legislature having jurisdiction over innovation, development, economic advancement and business matters and to the joint standing committee of the Legislature having jurisdiction over labor and housing matters and gives these committees authority to report out legislation based on the department's report.

The bill would strengthen research and economic development efforts across the University of Maine System to support Maine industries and workforce development and to foster business formation and expansion, specifically in the research and development sectors designated in statute: advanced technology for agriculture and forestry; aquaculture and marine technology; biotechnology; composite materials technology; environmental technology; information 4 technology; and precision manufacturing technology.

AN ACT TO EXPAND WORKFORCE ACCESS BY CREATING APPRENTICESHIP PROGRAMS TO INCREASE ACCESS TO LICENSURE IN CERTAIN OCCUPATIONS

This bill proposes to enact the Expanded Workforce Access Act of 2019, which will authorize the use of apprenticeships as an alternative means of obtaining licenses to 7 perform certain occupations. Occupations included under this Act may include, but are not limited to, barbering or limited barbering and nail technology. This bill will expand access to the workforce by allowing individuals to fulfill licensing requirements through participation in apprenticeship programs, thus allowing participants to earn a paycheck at the same time as they acquire hands-on training and experience.

Any institution of higher education with the power to grant degrees in the commonwealth that has any known liabilities or risks which may result in the imminent closure of the institution or jeopardize the institution's ability to fulfill its obligations to current and admitted students shall (a) notify the board of higher education of such known liabilities or risks; and (b) prepare and submit to said board, for its approval, a contingency closure plan which shall include a process for providing enrolled and admitted students and staff with timely notification of the institution's financial condition, accreditation status, and any outstanding compliance issues regarding federal student aid programs; arrangements for enabling students to complete their programs of study; and a plan for the transfer and long-term maintenance of student records in the event that the institution ceases to exist.
