# **DID YOU KNOW?**

On display in the north lobby of the Connecticut State Capitol is the original plaster model of a statue called "The Genius of Connecticut" by Randolph Rogers. The use of the word "genius" connotes that she is a protector figure or a symbol of the spirit of the people of Connecticut.

- The model was made in Rome and the 3.5 ton, 17 feet 10 inches tall figure was cast in Munich, Germany.
- The statue stood atop the Capitol dome from 1878 until 1938.
- The Genius was damaged during a storm in 1938 and, in 1942, it was donated to the federal government and melted down as part of the war effort to make ammunition and machine parts.
- The new bronze casting of the Genius is the product of a five-year project beginning in 2005, which cost approximately \$330,000.
- Due to an \$11,000 per month housing fee, the new statue was brought back to the State Capitol, where she rests on a \$30,000 marble base in the rotunda until another \$200,000 can be found to once again raise the Genius atop the Capitol dome.

### 2021 LEGISLATIVE ACCOMPLISHMENTS

#### CONNECTICUT

- A bill that allow sConnecticut college athletes to <u>profit off their names, images, and likenesses</u>, as well as make money through endorsements and hire an agent was signed into law.
- Lawmakers also adopted bills focused on college campus safety this session, including legislation that requires college campuses to <u>distribute a sexual misconduct survey</u> to students every two years.
- Another new law requires colleges and universities in the state to <u>include campus accidents resulting</u> in death or serious physical injury in each institution's annual crime and safety report.

#### MAINE

- The state passed <u>LD 1373</u>, which bans seclusion, chemical restraints, mechanical restraints and certain physical restraints of students in all Maine schools.
- <u>LD 325</u> allows students whose access to on-site education is limited as a result of a state of emergency, such as that resulting from the COVID-19 pandemic, to be classified as having experienced education disruption and eligible for school work recognition plans that will demonstrate achievement under Maine's system of learning results.

#### MASSACHUSETTS

Massachusetts legislators passed <u>S 2979</u>, which establishes that the state's postsecondary
institutions must conduct a sexual misconduct climate survey of all students at the institution every 4
years. A task force will be formed to review the surveys.

#### **NEW HAMPSHIRE**

• When Gov. Sununu proposed a two-year budget in February, its centerpiece was a <u>merger of the two</u> <u>systems</u>. Many involved in both systems, including former trustees from both political parties, opposed the move. Legislators never put it into the budget bill. Sununu's office said he remains committed to a merger.

#### **RHODE ISLAND**

- The Assembly made permanent the <u>Rhode Island Promise program</u>, which provides up to two years of free tuition for eligible Rhode Islanders at Community College of Rhode Island.
- Lawmakers budgeted <u>an additional \$5.9 million to assist Rhode Island College</u> with financial difficulties.
- The General Assembly granted <u>in-state tuition rates to all Rhode Islanders</u>, regardless of immigration status, for the state's public colleges and universities.

#### VERMONT

- Legislators may return briefly in October to deal with the arrival of funds coming from federal COVID relief.
- <u>H.138</u> appropriates \$3,600,000 in FY 21 from the Coronavirus Relief Fund to Vermont State Colleges to assist with pandemic-related expenses. If further funds are available in FY 21 or 22, then VSC is appropriated up to \$800,000 from the same funds to assist with pandemic-related expenses. VSC is granted an additional \$22,758,000 for costs and business disruptions through December 31, 2021 due to COVID-19.
- <u>H.183</u> requires the formation of a task force on campus sexual harm that would allow schools to share resources, information, and best practices to create more consistency across Vermont's campuses in the way schools respond to sexual violence.
