

COVID-19 Vaccine Requirements at New England's Colleges and Universities

JUNE 2021

After a full academic year of frequent testing, isolation and quarantine protocols, remote and hybrid learning and an overwhelming need for constant adaptability, colleges and universities in New England, and across the country, are looking toward a "normal" fall 2021 semester. But, what does "normal" mean in a post-pandemic world? What are the pros and cons of requiring postsecondary communities to be fully vaccinated? If campuses forego the COVID-19 vaccine requirement, how will they ensure a culture of equity and inclusion among students who are not vaccinated? These are the questions that institutions across the country are grappling with as the fall semester rapidly approaches.

In March, 2021, Rutgers University was the first institution to require students to receive the COVID-19 vaccine. Since then, many institutions in New England, the most vaccinated region in the country, have joined Rutgers in requiring students to be vaccinated against COVID-19 before returning to campus in the fall. Having a vaccinated population is the safest way to conduct a fall semester with a full-capacity campus. Moreover, fully vaccinated students will help to stop the spread of the virus in the communities surrounding our New England campuses. So, which New England institutions are requiring the vaccine for students?

AS OF JUNE 2021

87 (over 2/3) of New England's colleges and universities will require students to be fully vaccinated for COVID-19 for fall 2021: 60 private campuses and 26 public campuses

Some institutions including <u>University of Vermont</u> and <u>Northern Vermont University</u> have voiced their intentions to require the vaccine should it receive full approval from the FDA.

What does the CDC say?





Institutions where all students, faculty, and staff are fully vaccinated prior to the start of the semester can return to full capacity in-person learning, without requiring or recommending masking or physical distancing for people who are fully vaccinated.



When holding gatherings and events that include individuals who are not fully vaccinated such as campus visitors or others from outside of the institution, institutions should utilize appropriate prevention strategies to protect people who are not fully vaccinated.



People who are fully vaccinated do not need to undergo routine COVID-19 screening testing.



If a fully vaccinated person is exposed to someone with COVID-19 they do not need to be tested unless they are experiencing COVID-19 symptoms.



Institutions can be supportive of students, faculty, or staff who choose to continue to wear a mask for any reason.

If not requiring the COVID-19 vaccine, how are campuses encouraging students to get vaccinated?

Most institutions in New England that are not requiring students to receive the COVID-19 vaccine still state on their websites that they strongly encourage all members of the campus community to receive the vaccine.

University of New Haven and Sacred Heart University (CT)

University of New Haven (UNH) has replaced their COVID-19 case tracking dashboard with a vaccine dashboard to publicly convey the current vaccination rate of the campus community. Their goal is to reach an 85% vaccination rate by July 1 without requiring the vaccine. UNH will reevaluate vaccination protocol if this level of vaccination is not achieved.

Sacred Heart University, also in Connecticut, has taken a similar approach to UNH. In <u>recent communications</u> to the campus community, Sacred Heart's Coronavirus Planning Team expressed dissatisfaction with the current vaccination rate of students and stated its intention to require the vaccine should the rate of vaccination remain low.
